### **Alexandria City Law Enforcement Report:**

- Lieutenant Janice Parker Alexandria Sheriff's Office was present reporting on the status of the Sheriff's
  Office. Noting the work crews that are currently operating throughout the city. Lt. Parker noted that the
  work crews work in coordination with the City department of Parks and Recreation to help keep parks
  clean.
- Sgt. Jose Garcia from the Alexandria Police Department was present and provided general updates for the Arlandria City Manager area. Overall reportable crimes are down 22% for the same reporting period last year.
- APD continues to stress that residents not keep items of value in the car that can easily be seen, including GPS devices, sunglasses, owner's manuals and garage door openers that might be hanging from the visor. Please see Alexandria PD press release here:

### **Committee Reports:**

- A. Landscape Committee Leslie Thornton:
  - o The chairwoman has submitted her resignation.
  - Working on some landscaping designs and documentation describing exactly what the committee wants.
  - There are several projects on the table for the committee and will require a large amount of effort from committee members.
- B. Architectural Review Committee Jack Stevens:
  - o The committee did not hold a June meeting but did electronically review 2 variance requests.
  - o 3830 Elbert Avenue (LaVolpe) Approve new front door color but are pending approval for new door hardware color.
  - o 3807 Courtland Circle (Gorra-Stockma)- Conditional approval for replacement of 14 windows in a color that matches the current trim color (Sandpiper).
  - o Committee is continuing work on clarifying siding and paint specifications; this includes working with the vendors/manufacturers.
- C. Parking Committee Lewis Jackson:
  - There are issues with Henry's not reporting to the HOA when a vehicle is towed. The notification is to include the date/time/location as well as a photo of the violation.
  - o The committee is also looking into parking signage on upper Charles.
- D. Newsletter Committee Lewis Jackson:
  - The committee is fully functional and working on the summer 2011 Edition for August distribution, after national night out.

### Financial Report – Lewis Jackson for John Peterson

### Investments:

On May 31, 2011, the Association had operating and investment funds totaling \$549,117. There are \$530,516 in laddered CDs and investment funds. Total operating assets has a balance of \$18,601.

#### **Balance Sheet:**

The Accounts Receivable Residential Assessments account as of May 31, 2011 was \$54,900.

Accrued Reserves total \$535,820 and are fully supported by cash and investments. This signifies that the Association is in a healthy financial position.

### **Income Statement Report:**

The Income Statement Report reflects a year-to- date income of \$55,567 which is \$1,434 below the budgeted amount of \$57,002. The year-to-date expenses are \$57,618 which is \$615 over the budgeted amount of \$57,002.

Overall there is a negative variance between year-to-date income and expenses in the amount of \$2,050. As always, we will continue to closely monitor the monthly expenses for the association to insure effective fiscal management.

o Yard sale was very well trafficked and most residents had a good positive experience.

### B. Parking Policy Resolution

 The parking policy has been modified to reflect updated notification guidelines. New guidelines require 24 hour notice prior to towing for long-term parking violations. Violation notices will be placed on vehicles. The revised policy has been reviewed by the Board electronically and discussed in previous meetings.

# D. End Unit Garage Driveway Aprons

The current situation is an extreme eyesore, causes car damage and detracts from the overall aesthetic appeal of the community particularly during the spring real estate season.
